The spin-off and hive-down of the Daimler commercial vehicle business was completed with the entry of the spin-off and hive-down in the Commercial Register on 9
December 2021 and the Daimler commercial vehicle business was deconsolidated. As of 31 December 2021, Mercedes-Benz Group held a minority interest of 35% in
Daimler Truck Holding AG. The interest is accounted for using the equity method. The former Daimler Trucks & Buses segment is included in the Statement of Income as
discontinued operations and the Statements of Cash Flows until the date of its deconsolidation and is shown in the reconciliation. Also the financial services business that
would be contained in the Daimler commercial vehicle business in the future is included in the Statement of Income and the Statements of Cash Flows until the date of its
deconsolidation. However, it was part of continuing operations in the Mercedes-Benz Mobility segment.
