In the time period from 12 January 2026 until and including 16 January 2026, a number of 708,121 shares were bought back within the framework of the share buyback of Mercedes-Benz Group AG; the start of which was announced on 31 October 2025 pursuant to Art. 5 para. 1(a) of Regulation (EU) No. 596/2014, Art. 2 para. 1 of Delegated Regulation (EU) 2016/1052 for 3 November 2025.
